**TERMS & CONDITIONS**

1. The agency is required to submit the financial bid/quotation as per **Annexure –I** in sealed covers clearly super scribed "**Financial Bid/Quotation for Supply of furniture Items for DAA –List – D**" should reach the Principal, Govt. Polytechnic for Women Morni, Distt Panchkula (Haryana)
2. Late receipt of bids (i.e. after due date and time) will not be considered. Authorized representatives of the tenderers may participate in the tender opening meeting, in case they wish to do so.
3. Rates must be quoted in figures & words in INR including all levies and taxes (i.e. Sales Tax, VAT, and Service Tax, Transportation etc) as per schedule given in the financial bid.
4. **Literature, catalogue** etc. must be attached along with the quotation.
5. **Institution have the right to** see the physical sample of the items if it feels so before the delivery of items
6. The bid will be valid for 45 days from the date of opening of the tender. In the case of successful tenderer, rates quoted shall be valid till the supplies & installation are completed unless there is downward revision, in such case the benefit shall be *suomoto* transferred to this GPW Morni.
7. **Special discount/rebate (if any) admissible to Educational Institution/University may be specifically indicated in the quotation.**

8. GPW Morni may increase/decrease the final requirement from the quantity mentioned in the tender.
9. In case the successful bidder fails to deliver the items within the stipulated period, proceeding for black listing of the firm may be taken with appropriate authority of Govt.
10. Installation of the items will be the responsibility of the supplier.
11. Any or all representative may be present, of concerned firm, at the time of opening of quotations.
12. No cutting /overwriting will be accepted at rates.
13. Payment will be made after receiving the materials and successful installation of furniture as per the supply order and Guidelines. No advance payment will be released. The delivery will be made as per the supply order and deviation, if any, may attract penalty
14. **The firm shall repair any minor defect observed in the furniture items during the 6 months from the delivery of the items at its own cost** when intimated by GPW Morni in this regard
15. The representatives of the firm should be available on telephone and also on mobile to enable this polytechnic to call them in emergency situation. Therefore, telephone as well as mobile number(s) may also be given.
16. Each page of the financial bid is to be **signed by the tenderers and duly stamped**.
17. All disputes arising out of this contract shall be referred to the sole arbitration of the Principal, Govt. Polytechnic for Women Morni Distt Panchkula (Haryana). The venue of arbitration shall be Panchkula (Haryana).
18. GPW Morni reserves the right to reject any or all quotations without assigning any reason. The decision of GPW Morni in this regard shall be final. No enquiries in this regard shall be entertained. Correspondence during tendering process may invite disqualification.
